


How to whitelist for the BitCanna ICO

Step 1:

Go to the ICO panel by either clicking the whitelist button on the BitCanna website, or navigating manually: <https://www.bitcanna.io/register>. Fill in your account details, and mark the checkboxes.

Step 3:

Upload your documents. In order to be approved, make sure the photo is clear enough and the details of your document are readable. When you take photos of your ID-card, make sure to make a "selfie" with the card next to your head, and that you match the person displayed on the ID-card. Provide documents to all fields.
